In order for your \$500 non-refundable reservation list fee to be accepted, please agree to the following terms:

1. I understand and agree that my \$500 reservation fee is non-refundable. I am not guaranteed my puppy of choice or gender of choice; however, I understand that I can continue to defer my place in line and add myself to future reservation lists until I get the puppy I want and /or need.

_____ I understand and agree to the terms and conditions.

2. I also understand that the timing of litters is uncontrolled, as well as a successful pregnancy. We are not able to control the timing of heat cycles. We also have the right to cancel a reservation due to the best interest of the parents involved (the health of our parent dogs is paramount to having a litter). In the event a reservation list (breeding pair) is cancelled, I will be given other upcoming options. Heat cycles and timing is not guaranteed.

_____ I understand and agree that timing is never guaranteed.

3. When clients pay a non-refundable reservation fee, they are allowed to be on one reservation list and choose one puppy. If I want two puppies or to be on an additional list for a different litter concurrently, I understand that two reservation fees are required. The amount submitted for the two reservation fees will

be deducted from the total purchase price of the puppy(s) I choose. If I am on two reservation lists for two different litters and only choose one puppy, I will be removed from the other reservation list. I understand that I cannot use the second spot for a friend or family member.

_____ I understand that my reservation fee places me on one reservation list, and if I want an additional puppy, or to be on a different litter's list concurrently, an additional reservation fee is required. When I choose my puppy, my additional reservation will be removed from the list. It cannot be transferred to someone else.

4. I understand that I can be on two different dam's litter lists concurrently, but I will need to make a decision regarding which dam's litter I want to choose from, once my first opportunity to pick from a litter comes, or choose to remain on both lists until the time is right. I understand that the separate lists will progress at different rates, and I will be ranked by reservation fee submit date on both lists. At the time of my first opportunity to pick a puppy, both I may not be available.

_____ I agree to choose which dam's litter I want to choose from, once my turn has come.

5. I understand that the breeder has the right to reserve any puppy or puppies from any litter without notice for the preservation of their breeding program.

_____ I understand that the breeder reserves the right to reserve pick(s) of the litter.

6. I understand that clients choose in the order of the reservation list and clients can choose any of the puppies available to them at their selection time and placement. If a client is not reachable during their 30-minute selection timeframe, then they will forfeit their placement.

_____ I understand and agree to the selection day process.

7. I understand that I must read through the Dog Health Warranty, Purchase Agreement, & Spay/Neuter Contract and be familiar with the terms before submitting my reservation fee.

_____ I have read through the Dog Health Warranty, Purchase Agreement, & Spay/Neuter Contract, and understand and agree to the terms.
